1. The Student hereby states that s/he is under a contractual relationship with Szent Istvan University, and further states that s/he will register for the academic year in the first week of classes, but no later than October 14 for the fall semester or by March 14 for the spring semester.

2. The Student has submitted a request for accommodation in the dormitories via the NEPTUN student system, and has been notified of his/her acceptance to a dormitory, whereby s/he is authorized to accommodation at the
Dormitory, room number, for the period extending from(date) to(date).
3. The Student hereby states that s/he will be using the accommodation specified in section 2. The Student shall only be authorized to occupy the room designated for him/her. The Student is not permitted to transfer the accommodation and the services related to it to any other person. In the event that s/he does so, the Disciplinary Committee of the appropriate Faculty may launch proceedings. Exchanging rooms is only permitted in justified cases.
4. In consideration for the room and the related services, the Student must pay the fee set by the Senate of SZIU, and specified in the fee table found in the General Terms and Conditions.
5. Detailed regulations applying to the use of the room can be found in the General Terms and Conditions (GTC). The Student hereby states that s/he is aware of the provisions of the GTC and regards them as binding upon himself/herself.
6. The present agreement shall enter into effect for the duration of the term specified in section 2. Rules applicable to termination can be found in the GTC.
7. The Student hereby consents to the Dormitory recording and processing his/her data obtained through the present contract.
8. By signing this document, the Student hereby states that s/he is aware of all the rules applicable to the Dormitory.
9. The Student is aware that the Dormitory assumes no liability whatsoever for any damage to any valuables left in rooms, or for damage to the furnishings of the Dormitory resulting for improper use.
